INTRODUCTION

The present monograph should be considered as a "working paper in progress" rather than a complete study of the subject of illustrated envelopes used by the state and county departments which are represented by the monograph.

The compiler has collected the envelopes of this type for the many state departmental offices and county departmental offices which were used in Texas for much of the past decade. When similar covers were encountered from other states, primarily in eBay listings, an effort was made to "harvest" the images of these covers, and these were then preserved for some future use. A related series of similar studies is being prepared. The covers which appear here are primarily from my personal collection, but some are from the archives of "harvested" covers. Credit to the source is given in those instances where I properly recorded where I found it.

These covers were printed and distributed and sold by several different printing companies. The most prolific of these was **Clarke & Coates**, located in Galveston, Texas, which later used the imprint of **Robert Clarke & Co.**, also located in Galveston.




Figure 1. An illustrated cover from Clarke & Coates Stationers, dated June 7, 1906. Clarke & Coates was a major supplier of the illustrated envelopes used by many Texas county courthouse offices and departments. Image at 75%. Author's collection





Figure 2. Another illustrated cover from Clarke & Coates Stationers, dated Sept 20, 1910. Image at 75%. Author's collection.

A small number of these covers have been seen with an imprint of **Geo. D. Barnard & Co., St. Louis, Mo**.



The basic design used for most of the Texas courthouse covers consisted of a fivepointed shaded star in the center of the envelope, which is surrounded by a wreath, and looks similar to the state seal of Texas. At the upper left corner is an ornate corner card design, which has been recorded in three basic shapes: oval, rectangular, and circular. There appear to be many different variations of the oval design, especially in the lettering used in the "AFTER TEN DAYS RETURN TO" printed statement at the top of the oval. The corner typically includes the official's name, office, county, and post office name, but there is no apparent pattern for the layout of these elements, and a wide variety of font types and arrangement of the words have been encountered. It appears that the printer's catalog which would have been used to place the order must have given the customer considerable flexibility in choosing how he wanted his information to appear.

A preliminary summary of the different styles of corners are shown in the tables on the accompanying pages. No effort has been made at present to try and make a detailed classification of the corner card designs.

The covers are organized alphabetically by county. In most instances, the location of the office is at the county seat and courthouse. An exception is found occasionally for covers from an office of the Justice of the Peace or County Commissioner, which list a town name other than the county seat. Within the county, the covers are organized by name of the office, and then chronologically when multiple examples are present with slightly different text layouts.

Each cover illustrated will have a header section with the following information provided.

The fields are generally self-explanatory, but some comments are in order.

- a.) The **ID**: field is reserved for future use should it become practical to assign some form of classification to the different types of covers.
- b.) The entry in the **Dates:** field will generally be limited to the year, and when two identical covers are known from different years, a range may be provided.
- c.) The **Size:** field will be provided in inches, i.e., 6.25" x 3.75", when the actual cover can be examined, but more often will be noted as "Small", "Regular (appears to be

equivalent to the current No. 6 size envelope, which is 6.5" x 3.675" size), or "Large" (equivalent to our current legal size No. 10 envelopes).

- d.) The **Color:** field will be approximate, as many colors seen online are not truly representative.
- e.) The **Office:** field will include the name of the departmental office as it appears on the envelope. As the departmental name may change over time, covers with alternative departmental names (or office holder's names) will generally be included following the earliest version of the department name.
- f.) The **Notes:** field will include information about the printer's imprint, when present. If not mentioned, there was no imprint, or the reverse of the cover was not available

Only the front of the covers will be included in the illustrations unless there is some significant postal history element on the reverse. When the cover included contents related to the purpose of the cover and office, the contents, or at least the illustrated part of the letterhead is also shown.

The original intention was to limit the scope of these monographs to those with the conventional all-over illustrations. Several of the Texas counties apparently chose to have local printers prepare illustrated envelopes with the design of the county courthouse, and after some reflection, it was decided to include these covers as well. In a few instances, a cover from a county office with only the standard return corner card has been included. These were added when their presence might be helpful to identify the timeframe for the transition from the use of the all-over illustrated covers to another format, or in a few instances, simply because they were available.

A few of these covers also included the original contents. When the contents were related to the departmental office, and included illustrated stationery or designs, they were also included.

A few covers with these designs have been encountered which were printed for use by private individuals or businesses, usually a law firm or land/real estate agency. These are included in the **Appendix A** at the end of the monograph.

A second monograph has been prepared for similar illustrated covers used by officials in the various departments of the Texas state government located in Austin, Texas. This study is also available from the author upon request.


